### Recruitment

We have recruited 130 patients since our first site was Greenlit in mid July. Our biggest recruiting site so far is University Hospital Dorset who have recruited an incredible 32 patients. CONGRATULATIONS!

## **Urine Samples**

Reminder: The lab are receiving high numbers of unlabelled samples so please populate the SNAP2 patient ID and womans Date of Birth on both the lab form and urine sample tube label.

# Follow Up Visits

Following Randomisation please ensure you add the participant to the main REDCAP database and complete all of the baseline questionnaires.

Please ensure you book in the study follow up appointments at 6, 12, 26 and 52 week timepoints.

If you cannot get hold of the participant for an arranged follow up call, please attempt a minimum of 3 times over 3 different days. Please do not withdraw the patient and re attempt the next scheduled follow up call as usual.

## **Medication Changes TIPS**

When you add a new prescription, please add all medication into the one prescription and advise women to do the same when they self-report their current medication.

After you have saved the px, select 'SEND to patient' button to activate it. The ppt will recieve a notification and a text.

## My BP care new dropdown on patient profile

There is a new dropdown feature on the My Pregnancy care HCP Dashboard. This is to help communication between the trial team and site teams. Please use this to log any actions on flags.

## New Trial Manager

### Some guidance for self-management participants Adding participants:

- When adding a participant to the dashboard, remember to add their baseline medication.
- Please provide GP postal and/ or email address so these details can be verified promptly.

### **Dashboard monitoring:**

- If a BP reading flags for action, allow the participant time to contact their midwife/ MAU through usual care routes before the research team intervenes. In some cases, personnel will overlap.
- The App will prompt the participant to confirm if they have contacted a healthcare professional 24 hours after a flagged reading. Use clinical judgement to act on any specific concerns about individual participants on the dashboard.

### **Communication:**

• Inform your maternity assessment unit/ triage/ community midwives about the SNAP2 study. Your equipment packs contain a poster stand with information for healthcare professionals to refer to.

#### **Dashboard cover:**

- Dashboard cover is designed to be during working hours.
- Participants should be made aware of who to contact, including out of hours, during enrolment.

#### **Qualitative interviews**

 During the screening and consent process, please ask participants if they would like to take part in an interview. This is important for our evaluation work! Even if they are not taking part in SNAP2 we would still like to talk to them to find out about their experiences.
